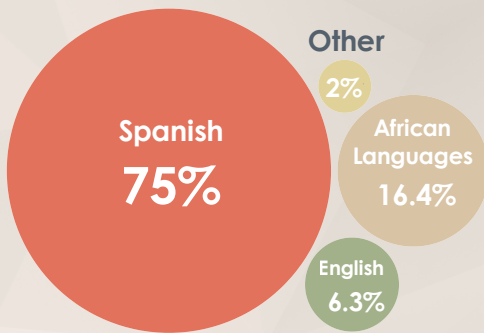

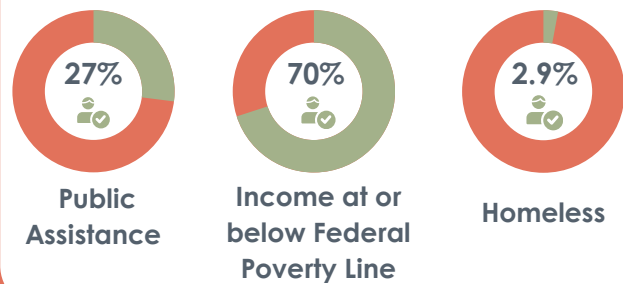
2024-2025 Program Year Enrollment

CentroNía is a nonprofit, community-based organization dedicated to educating children and youth while strengthening families in a bilingual, multicultural environment. Our Early Head Start program supports infants, toddlers, and pregnant women from low-income households, helping build the foundational skills needed for children's school readiness and overall family well-being. We offer a dual-option program with both home-based and center-based services, tailored to meet the specific needs of the communities we serve.

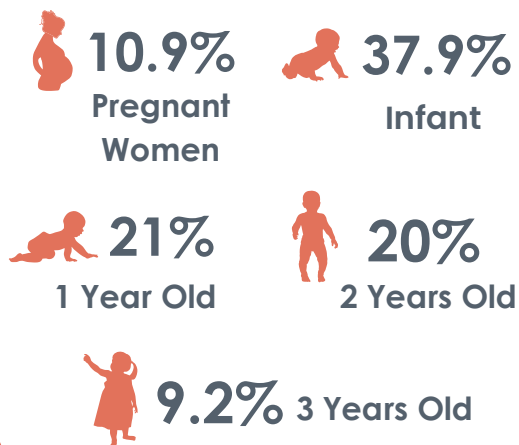
Primary Languages of families

Cumulative Enrollment



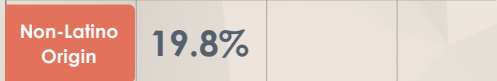

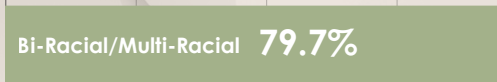
CentroNía EHS provided medical and wellbeing services to all 26 pregnant women enrolled such as:

Service Delivery: Dual-Option Programming

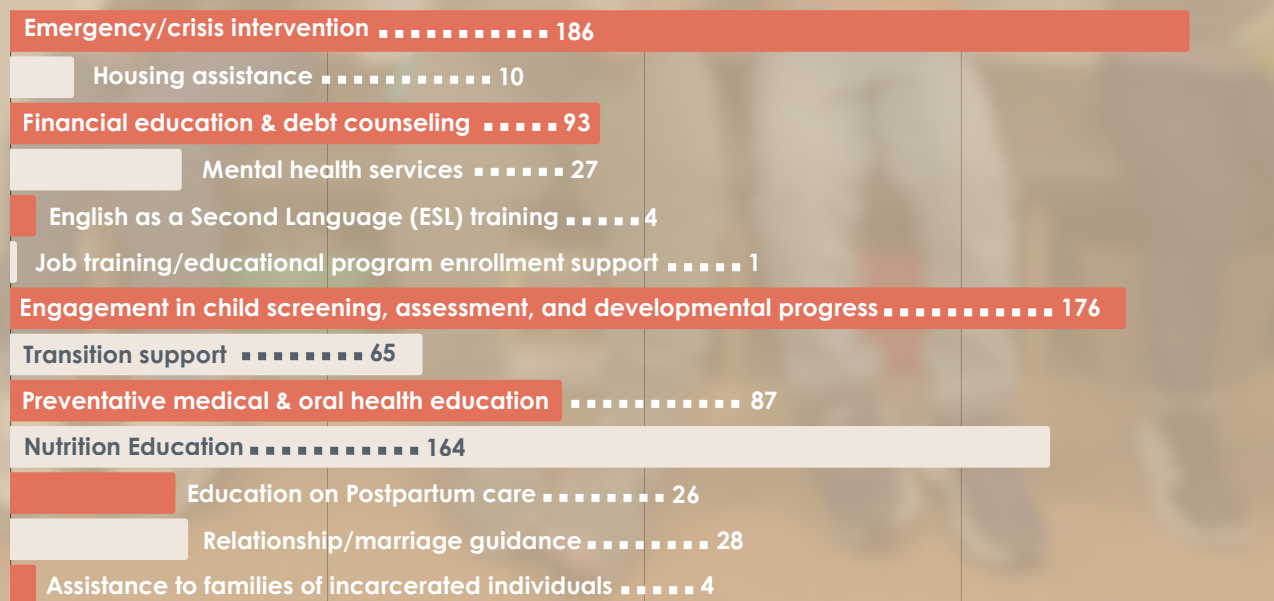
112 home-visiting slots

Home visits reach families where they live by delivering family support and child development services directly to the home environment. Children and expectant women enrolled in CentroNía’s home visiting program option receive prenatal, postal, and/or developmental screenings, guidance on learning and developmental milestones, social support, referrals to ancillary community services, and linkages for enrollment in public benefits.

32 center-based slots

Families with two-year-old children enrolled in CentroNía EHS’ center-based program option receive education and child development services primarily in classroom settings. CentroNía has two EHS classrooms in Takoma Park, MD, and two at its Upshur Street center in Washington, D.C.’s Ward 4. Staff members visit family homes at least twice per year as part of their larger efforts to promote secure parent-child relationships and safe home environments, and to help parents get the most out of learning experiences available to young children during their day-to-day routines.

Family Engagement

Our family engagement activities are designed to strengthen the vital connection between home, school, and community. By offering workshops, resources, and events that empower parents and caregivers, we ensure families are active partners in their children’s learning and development.

These services not only provide parents with the tools to support academic success but also create opportunities for families to build relationships, share experiences, and access community resources. Strong family engagement fosters a sense of belonging, strengthens social networks, and contributes to a thriving community where children and families can grow and succeed together.

Socializations for Families: Learning, Sharing, Growing

Socialization activities take place twice a month per Home Visiting Group (one in-house, one off-site), totaling six each month. These activities support child development and family learning, building on home visit goals. In-house activities include workshops on nutrition or dental care, while off-site trips feature places like museums, water parks, and the aquarium.

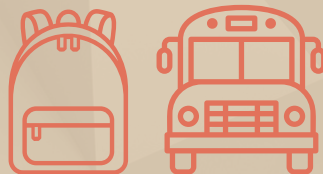
All activities align with the curriculum and provide enriching developmental experiences.

Power in Partnership: Building an Impact

CentroNía EHS partners with public and private organizations to offer a range of family support activities, including free dental services, parent council meetings, and workshops on tax prep and parenting. Staff maintain a regularly updated list of community resources and services, which is tailored to the specific needs of families. These services include support for health, mental health, nutrition, child welfare, parenting, early intervention, special education screening and assessment, life skills, housing assistance, and child care subsidies.

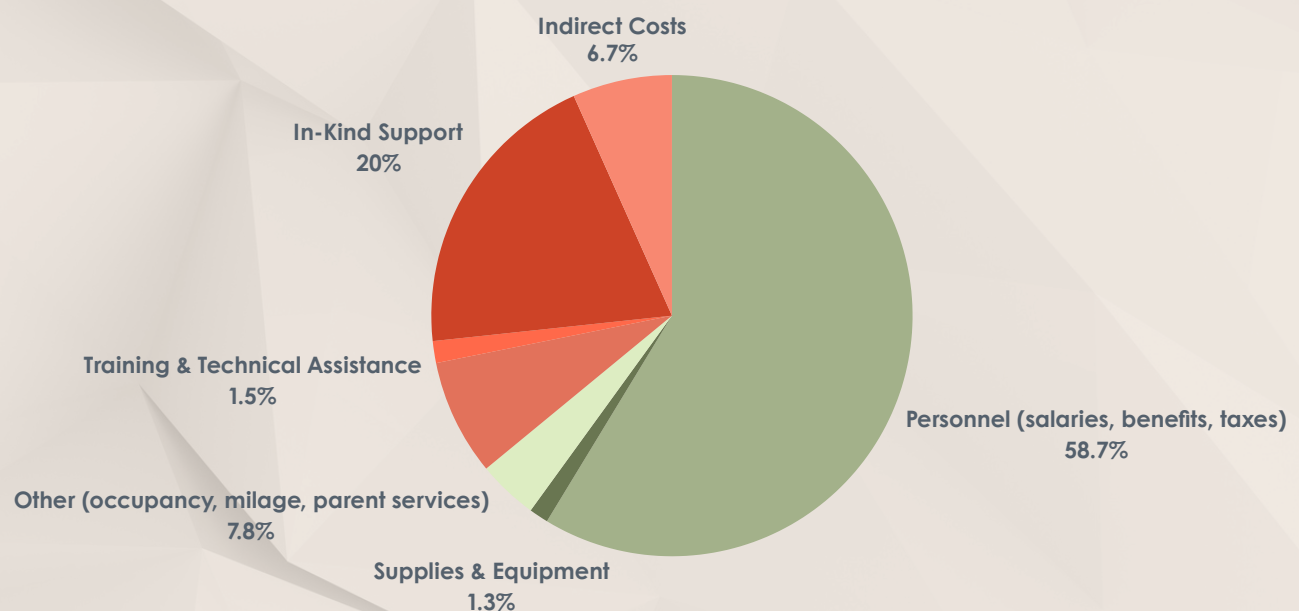

CentroNía EHS 2026 Budget Projection

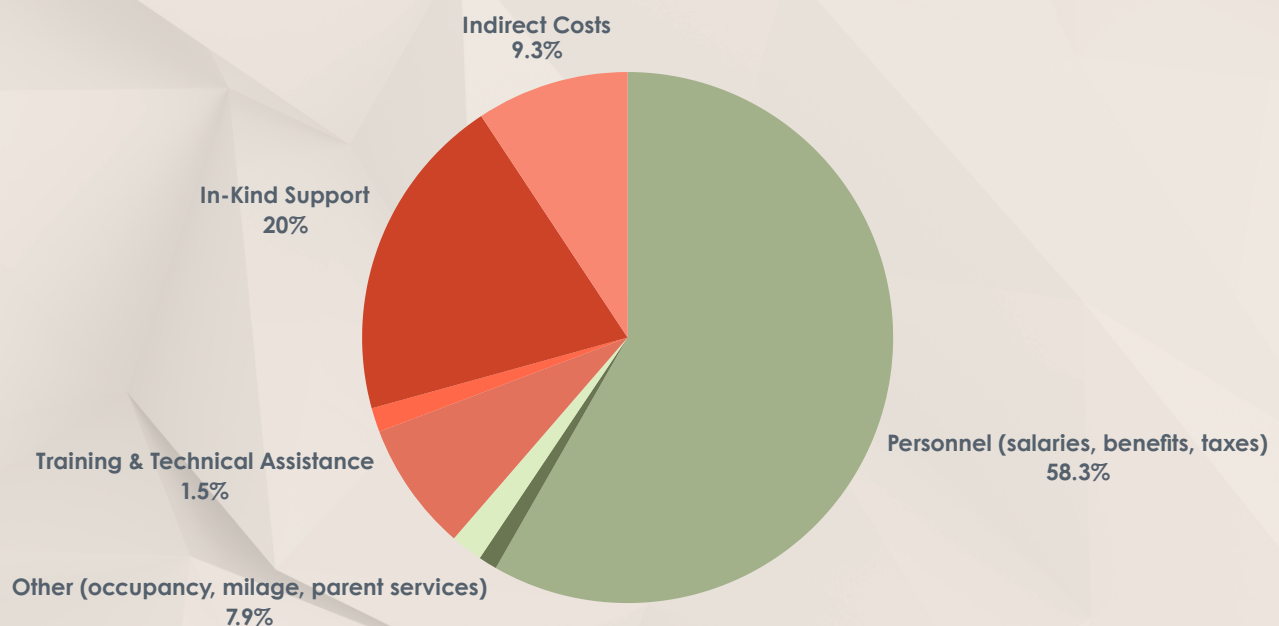
